MONTHLY SUMMARY

- The Munro Climate Change Leaders Fund returned -0.7% net for November, underperforming the benchmark return of -0.2% by 0.5%.
- After a brief wobble in November, equity markets recovered late in the month, supported by growing expectations of a Fed rate cut and a rebound in sentiment as concerns around an AI-driven market bubble eased.
- Key contributors to performance for the month were Nextera Energy (Clean Energy), Legence (Energy Efficiency) and Clean Harbors (Circular Economy).
- Key detractors from performance for the month were CATL (Clean Transport), Nvidia (Energy Efficiency), and Schneider Electric (Energy Efficiency).






